Certification of statewide officer elections (Nominations & Elections Committee)
 Results of the election were presented by the Nominations and Elections Committee. Motion

Tracy asked Tyler, Bonner and Tim to collaborate for filling the statewide membership chair and state grievance officer appointments.

2. FY21 State ASF Board budget proposal (Lori Wynia)

Lori presented an FY 21 budget proposal. Lori also introduced the cost of adding 10% release of local presidents, which currently would cost about \$43,900. While our current balance could cover this, we couldn't do it ongoing. A 5% would be about \$21,500. Tracy also noted that ASF's financial agreement with Teamsters needs to be renegotiated this year. There is also the factor of Teamsters not currently paying a state grievance officer for ASF directly. Josh asked about possible impacts of campus budgets and impacts on our members (layouts, etc.) Another possible way to spend our revenue is to increase campus support to engage members; Jill suggested this might be a one-time increase in campus support for now.

The proposed budget will be sent out to the Board and it will be considered and approved at a future meeting (June 8). Without objection, the budget was tabled until the June 8 meeting.

3. Contract ratification & legislative update (Sami Gabriel) House floor vote for contract ratification will be this afternoon. If it passes. It will then go to the Senate. Senate vote is expected to be held off to the end. If the Senate votes it down or they don't take a vote, the contract is not enacted. If that happens, there would be attempts to renegotiate. The testimonials from our members went forward and these will be used with legislators. The bottom line cost of the state contracts is about 5 million/month. Stewards

Town Hall will be held today to give tips about how to talk to members.

4. State President update
